# Summing Up the 88th Legislative Session

Delivering a worthy scorecard is a mighty chore. Thank you for your patience as we worked to create a balanced picture of how your elected officials supported the values we share during the 88th Legislative Session.

This year we witnessed many of our lawmakers were finding it easy to spend your money, pick winners and losers, indoctrinate your children, ignore our border and national security, promote immorality and addictive behaviors...and at the end of the regular session, watching House members break the law themselves by failing to follow the rule of law in the Paxton impeachment trial. Some scores are lower than we wished to see - but it is important to take an honest look at how people vote after are elected to office.

Thankfully, lawmakers did pass good bills protecting childhood innocence by banning graphic sexual books from school libraries, protecting children from trans-related mutualization, and allowing college women to compete only against other biological women.

Texas lawmakers also removed hundreds of Diversity, Equity and Inclusion (DEI) employees in our universities from positions that existed only to push racism and victimhood. And children will be banned from using hard-core porn sites – a bill that almost every legislator voted for on both sides of the aisle. It is refreshing to see them unify to help kids have a happier and healthier future. While Governor Abbott signed these bills to become effective September 1, several are still tied up in court battles. We expect all our new laws to be upheld by good judges who allow sanity to prevail.

Sadly, children in most schools will continue to be subjected to egregious daily mental health assessments, quizzes on sexual habits, and surveys on their personal values without a parent's approval. The celebrated sex-ed opt-in that passed last session will expire next year. House committees killed these bills and others that would have protected parental rights in education. We would like our laws to require our schools to focus on providing students the intellectual tools they need to learn to reach conclusions based on logic and evidence rather than focus children on emotions and feelings.

Four bills enabling government-sanction gambling raced through a committee hearing with profiteers touting the goodness of "helping gamblers," while family supportive groups and religious organizations spoke the truth about the addictive and destructive nature of gambling on a society.

Marijuana was nearly decriminalized for under 2 ounces (200 small joints with THC content 10-48 times higher than marijuana in the 80's and 90's). The Senate thankfully stopped these bills in their tracks. The five months of the session were a whirlwind – late nights, early mornings, long hearings and crazy demonstrations. After a late hearing on SB 14, banning minors from medical procedures to "transition," we had to climb over splayed bodies of trans-activists "playing dead" in every passageway out of the extension. Drag Queens paraded through the Capitol, and men flagrantly used women's restrooms, while school groups toured the Capitol.

We had wonderful conversations with many Senators, Representatives and/or their staff. TEF continued to build relationships that encourage ongoing and respectful discourse on issues that matter. We hope to have more of our elected officials on our side – the side of families – without which we will cease to have a free and amazing nation.

Thank you for standing with us this session. The calls you made or emails you sent are the reason many good bills were passed. When you share our alerts and the Torch Newsletter with your friends you multiply your own efforts to keep Texas the best place to live. Your financial support is invaluable.
